THE REAL RISKS OF POOR ONBOARDING

Supplier onboarding isn't just a box to check. If done poorly or too late, it becomes a **risk accelerator**. Without visibility and control, organizations expose themselves to serious financial, regulatory, and reputational damage.

FINANCIAL RISK: FRAUD, WASTE, AND DUPLICATE SPEND

- **Fraudulent** or misrepresented suppliers can cost hundreds of thousands in losses
- **Duplicate** suppliers and invoice fraud slip through when controls are weak
- Without early **risk signals**, bad actors make it past the gates

COMPLIANCE RISK: REGULATORY PENALTIES & DETENTIONS

- **New regulations** (like UFLPA, CSRD, and DORA) require proactive supplier vetting, not just passive compliance.
- **Enforcement** is ramping up, and violations can lead to fines, shipment delays, or even contract cancellations.

REPUTATIONAL RISK: ACCOUNTABILITY STARTS AT ONBOARDING

- Stakeholders demand **transparency**. If you can't track ownership, labor, or ESG risks, you're exposed

FOUR FRICTION POINTS THAT SABOTAGE ONBOARDING

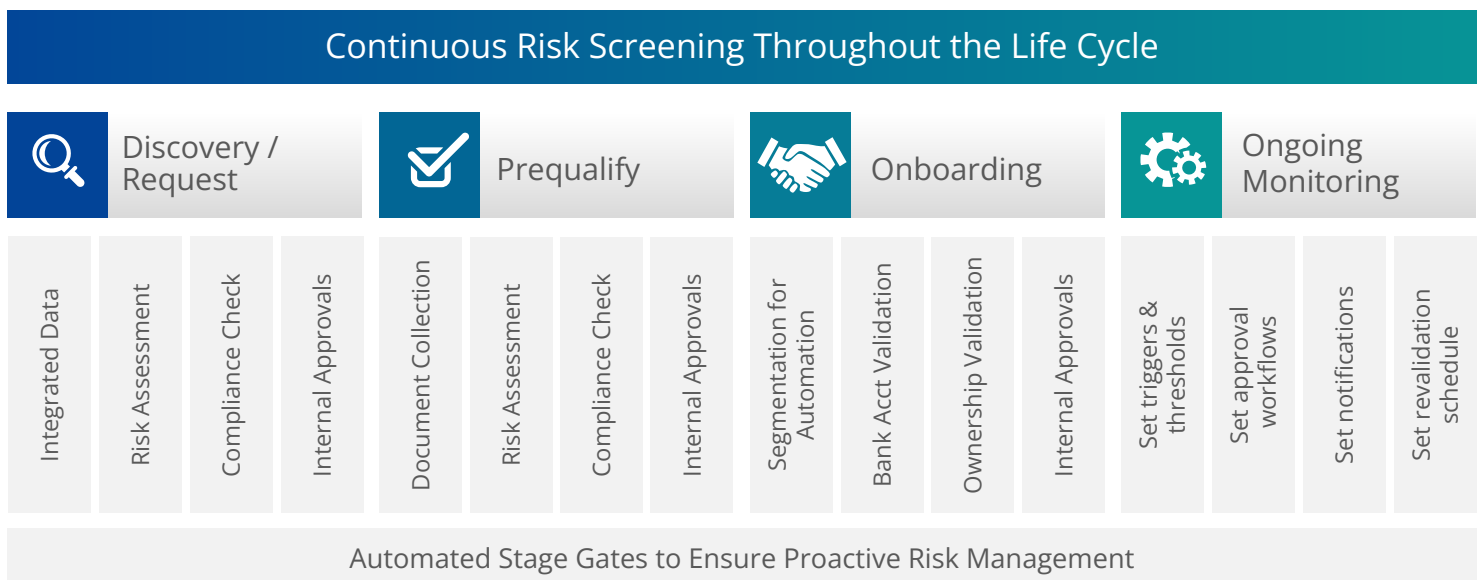

BT Sourced, the procurement arm of British Telecom, needed to onboard hundreds of suppliers quickly, across different categories, regions, and risk profiles.

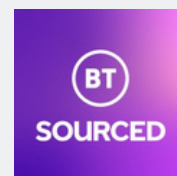
